


Share Purchase Plan Share Issue Completed

Breaker Resources NL (ASX: BRB, **Breaker**) is pleased to confirm that the allotment and issue of all fully paid ordinary shares (**Shares**) subscribed for by both eligible shareholders and sub-underwriters under the recently closed Share Purchase Plan (**SPP**) has been completed.

The Company advises an amendment to the details announced in the ASX release of 31 May 2016 regarding the funds raised and number of shares subscribed for by eligible shareholders. Under the terms of the SPP, holders of partly paid shares were eligible to subscribe for Shares and several did so, however these subscriptions (\$9,000 representing 69,232 Shares) were inadvertently omitted from the final calculations.

On this basis, the total amount raised from the SPP was \$1.095 million and the number of Shares subscribed for by eligible shareholders is 8,423,133. In addition, sub-underwriters to the SPP elected to participate in a top-up placement raising \$500,000, of which \$400,000 has been received, representing 3,076,923 Shares. The balance of \$100,000 is subject to shareholder approval at the general meeting to be held on 10 June 2016.
